MAKE OATH AND SAY AS FOLLOWS: -		

- This Sworn Witness Statement is supplemental to those Sworn Witness Statements made by me on 13th May 2022, 29th June 2023, 6th July 2023 and 12th March 2024. I use the same expressions and abbreviations as in my previous Sworn Witness Statements. I make this Sworn Witness Statement in order to correct the contents of paragraph 10 of my Fourth Sworn Witness Statement.
- 2. The contents of this Sworn Witness Statement are true to the best of my information, knowledge and belief and the facts stated herein are known to me personally unless otherwise stated. Where the facts stated are not known to me personally I have stated the source of my information. I have also relied on a review of documents in my possession or control.
- 3. At paragraph 10 of my Fourth Sworn Witness Statement I provided a list of GPA meetings held in 2020. After revising the dates provided I have noticed two errors within the same:
 - reference to a GPA meeting of the 1st June 2020 has been inadvertently omitted (I would refer to paragraph 26 of my First Sworn Witness Statement dated 13th May 2022 which details this meeting and Document No.10 of Appendix B to my Sworn Witness Statements which is a minute of the meeting held on the 1st June 2020); and
 - (ii) reference to a GPA meeting of the 6th July 2020 has been inadvertently omitted. The reason for this being that a reference to a GPA meeting having been held on the 6th June 2020 has been included in error due to the erroneous dating of the minutes of the GPA meeting held with the GPF on the 6th July 2020. The contents of the email

reproduced at the bottom of the minutes for the meeting held (sent to me by the Federation Chairman, Mr Morello, on the 22nd June 2020) is consistent with the correction in meeting dates. The email refers to Mr McGrail's "*resignation*" and Mr Ullger being interim commissioner, which was not the position on the 6th June 2020. (I would refer to (a) paragraph 5 of my Second Sworn Witness Statement dated 29th June 2023 (b) the minutes of the meeting held, a copy of which can be found at Document No.28 of Appendix B to my Sworn Witness Statements and (c) a copy of the email received from the Federation Chairman which can be found at Document No.29 of Appendix B to my Sworn Witness Statements, in this regard).
