SECOND WITNESS STATEMENT OF COMMISSIONER OF POLICE RICHARD ULLGER

Introduction

- My name is Richard Ullger and I am the Commissioner of Police with the Royal Gibraltar Police [RGP]. This is my second statement to the Inquiry and it is done so in order that I may tender in evidence exhibits that are relevant to my statement.
- 2. On page 2 of my first statement dated 17th November 2022, paragraph 8, I make reference to an exchange of emails between the Deputy Governor, Nick Pyle and I in relation to comments about my application for Commissioner of Police in 2017. I now tender these in evidence as **Exhibit RU1**.
- 3. On page 5 of my first statement, paragraph 17, I make reference to an email that was issued to the work force by Mr McGrail's Staff Officer, which was in relation to the consultation, recommendations and work streams arising from the AAP evaluation of the RGP. I now tender this in evidence as **Exhibit RU2**. I also would like to tender in evidence the AAP final report as **Exhibit RU3** and the AAP Recommendations Worksheet as **Exhibit RU4** to address the key issues. Further to this, I tender in evidence as **Exhibit RU5** a thread of emails between Mr Morello and me, between the 28th of August 2019 and the 30th of August 2019, relating to a disagreement between us in relation to the AAP work streams.

These are now tendered in evidence as Exhibit RU7. A warning letter was then served upon Mr Morello because of his conduct and I tender a copy of this warning letter as Exhibit RU8.
- On page 7, paragraph 21 of my first statement, I make reference to two
 regulation 9 notices. I now tender in evidence two copies of these as Exhibit
 RU9 and Exhibit RU10 respectively.
- On page 7 of my first statement, paragraph 22, I make reference to two
 regulation 9 notices. I now tender in evidence two copies of these as Exhibit
 RU11 and Exhibit RU12 respectively.
