4. It is therefore clear that I did not state that the complaints received by the PCB were about Mr McGrail's conduct in the Airport Incident itself but about the narrower allegation that Mr McGrail had acted outside the remit of the search warrant in question. I then went on to state in that same paragraph that our investigation revealed that Mr McGrail had not been involved in the execution of the search warrant nor had he been involved in the search of the premises. His only involvement had been to apply to the Gibraltar Court on behalf of the Royal Gibraltar Police for a warrant to enter and search the JPSU. The PCB did not find that Mr McGrail had abused his authority.

5. My replies to the questions put to me at numbered subparagraphs 1a to d are as follows:-

(i) Question 1a

The finding of the PCB that it had not found that Mr McGrail had abused his authority was communicated to the GPA whose members included the Chief Secretary of HMGOG, Mr Darren Grech, and the then Deputy Governor, Mr Nick Pyle. This finding was not communicated to anyone else apart from the complainants and the professional standards department of the Royal Gibraltar Police.
