## INQUIRY INTO THE RETIREMENT OF THE FORMER COMMISSIONER OF POLICE

Convened by a Commission issued by His Majesty's Government of Gibraltar on 4<sup>th</sup> February 2022 in Legal Notice No.34 of 2022

## 2<sup>ND</sup> WITNESS STATEMENT OF A/DETECTIVE SUPERINTENDENT GARY SMITH

- 1. Further to my statement dated 18 November 2022 and in response to the Triay Letter on 14 June 2023 I received via Nick Cruz, CruzLaw LLP, originating from Triay Lawyers, on 14 June 2023; Triay Lawyers seek clarification into the following:
- a. Please confirm when your provisional findings were made available to Mr McGrail and or to Mr Picardo/Mr Pyle.
- 2. As per paragraphs 14 and 15 of my statement made 18 November 2022, on 6 June 2020, I wrote to Ian McGrail informing him of the Metropolitan Police Services' decision to pursue criminal charges against two RGP officers for their role in Operation Kram. We had a brief email exchange on 8 June 2020 whereby he asked for the specifics of the criminal offence(s) being considered.
- 3. On 9 June 2020 I was informed that Ian McGrail would no longer be available and that all future correspondence should be directed to the new Commissioner of Police Richard Ullger.
- 4. On 2 August 2022, Attias & Levy, provided a list of names and individual bodies alphabetically A to V. The Chief Minister, Mr. Fabian Picardo is referenced as (B) and the Deputy Governor of Gibraltar, Mr Nick Pyle is referenced as (E).
- 5. I have listed those individuals I had contact with and drew reference to those I had not, in paragraph 5 and 6 of my statement dated 18 November 2022. For clarity, I have had no dealings with either Mr. Picardo or Mr. Pyle during the course of this investigation.
- 6. I am aware that RGP completed an internal report relating to Operation Kram and I believe this is the report refer to. I reiterate paragraph 39 of my first statement.

- 7. Paragraph 41 of my statement dated 18 November 2022 references the following four documents:-
  - (i) File of evidence pertaining to the criminal investigation;
  - (ii) Organisational Learning Report for RGP;
  - (iii)Discipline case report;
  - (iv)Coroner's Report.
- 8. For clarity, below I provide the dates passed and to whom:
  - (i) December 2020 DSU John Field, RGP;
  - (ii) September 2020 DSU John Field, RGP;
  - (iii)June 2021 AC Cathal Yeats, RGP;
  - (iv) July 2021 Charles Pitto, Presiding Stipendiary Magistrate/Coroner.
- 9. I confirm all four documents were never shared with Ian McGrail and were completed post his departure.
