#### SECOND WITNESS STATEMENT OF ASSISTANT COMMISSIONER OF POLICE CATHAL YEATS

#### Introduction

- 1. My name is Cathal Yeats, and I am the Assistant Commissioner of Police. I am in my 26th year of police service and have been the Assistant Commissioner since July 2020.
- 2. I write this statement in answer to provide the Inquiry with documents that I refer to in my first witness statement of the 21st November 2022 and which are relevant to the "Inquiry into the Retirement of the Former Commissioner of Police", Mr Ian McGrail.
- 3. For clarity all references I make to numbered paragraphs in this witness statement refer to paragraphs in my first witness statement dated the 21<sup>st</sup> November 2022.
- 4. In paragraph 10 I refer to a note with Chief Minster Fabian Picardo on Operation Delhi, I now tender this note as **Exhibit CY1**.
- 5. In paragraph 13, on Operation Kram, I refer to an email from the commissioner's personal assistant to me containing a letter from Mr Robert Fischel KC dated the 14<sup>th</sup> of May and the commissioner's reply of the 15<sup>th</sup> of May. I tender the email and both letters at **Exhibit CY2**, **CY3** and **CY4**.

- 6. In paragraph 14 I refer to an emailing the DPP arranging for a meeting on the Fischel letter, I tender these emails as Exhibits CY5, CY6, CY7 and CY8.
- 7. In advance of the meeting I exchanged emails with the DPP containing the 14<sup>th</sup> May letter from Robert Fischell KC and Commissioner McGrail's reply of the 15<sup>th</sup> May. I tender these emails as **Exhibits CY9 and CY10.**
- 8. In paragraph 15 I refer to the meeting with the DPP, I took notes with I tender as **Exhibit CY11** which I transposed onto my daybook, **Exhibit CY12**.
- 9. In paragraph 16 I refer to a letter from Mr Robert Fischel KC of the 19th of May, I tender the email and letter as **Exhibits CY13 and CY14**.
- 10. In paragraph 17 I state that I replied to Mr Robert Fischel KC on the 20<sup>th</sup> of May, the letter is **Exhibit CY15**.
- 11. In paragraph 19 I refer to the email I wrote to the attorney general on the 20<sup>th</sup> of May, the email and his response I tender as **Exhibit CY16**.
- 12. In paragraph 25 I mention receipt of the "Misconduct Report" I now tender the email from DCI Rawlinson and the report as Exhibit CY17 and CY18 respectively.
- 13. In paragraphs 28 and 29 I refer to a complaint lodged with the Police Complaints Board in relation to the runway incident. I provide copies of the documentation in my possession as **Exhibit CY19**, **CY20** and **CY21**.
